A motion was made by D. King, with a second by A. Gallagher, to adopt the resolution as drafted by the town attorney. Motion carried 5-0.

T. Dziewit asked if anyone could give him the time frame for which he can contest the action. No one knew the answer.

W. Keller said if he is serious about it, he could contact the Department of State and they would know if he would contact them.

Carrie Sloan commented on an unidentified man's comment about "asshole flatlanders" and said the flatlanders have some insight. They have been through this before and don't want to see it happen here.

D. Darling referred to information from an email regarding upcoming training.

On a motion by W. Keller, with a second by D. Cole, the meeting was adjourned at 8:11 p.m.. Motion carried 5-0.

- D. Cole will be a voting member in the absence of F. Ciulla.

The secretary printed the wrong minutes and a motion was made by W. Keller, with a second by A. Gallagher, to review the minutes for approval at the February meeting. Motion carried 5-0.

Karley Bessez was present regarding a subdivision application for property off Middlebrook Hill Road. D. Darling explained he had not submitted the notice for the public hearing to the legal publication, which changed to the Mountain Eagle. Therefore, the hearing will have to take place at the February meeting. However, planning board members reviewed the application. She provided the survey map which showed the location of the percolation test. She was asked to bring it all back next month.

Dave Miller was present regarding a possible subdivision on O'Dell Lake Road. It involves three tax parcels which he wished to recombine into a single parcel that he is conveying to the Watershed. He is making it a single tax entity. They are all whole parcels. D. Darling said there was a similar circumstance before, however, there is nothing in the town's subdivision regulations regarding the consolidation of lots. The planning board has no concerns with the consolidation of parcels. N. Brower said it depends on the level of review. Boundary line adjustments can deal with the combination of parcels or the county tax department can erase the lines with the filing of a survey map showing it as one to be filed. A letter describing the parcels will be written and he will return to the planning board with the changed survey map.

Bill Boyle, who was not present, is proposing a boundary line adjustment that was presented by board member D. King. It will combine the business property on state Rt. 23 with the old farm parcel across the highway. He will be putting the lots back together (previously subdivided) around the old barn and houses. There is a completed application and a sketch plan for the planning board's review.

A motion was made by D. King, with a second by D. Cole, to classify it as a boundary line adjustment. Motion carried 5-0.

A new deed was produced and the new deed and a new tax nap and description must be returned to the planning board.
