RESOLUTION NO. 017

**RESOLUTION SCHEDULING A PUBLIC HEARING ON A LOCAL LAW OF THE
TOWN OF HARPERSFIELD TO REGULATE AND CONTROL DOGS WITHIN THE
TOWN OF HARPERSFIELD**

WHEREAS, the Town of Harpersfield (the "Town") desires to enact a law to control and regulate dogs within its borders and provide uniform guidance on the registration and control of dogs within the Town of Harpersfield; and

WHEREAS, Pursuant to Section 10 of Municipal Home Rule Law, the Town is authorized to adopt such a Local Law establishing rules and regulations for dogs within the Town of Harpersfield; and

WHEREAS, it is the desire of the Town Board to accept the law as proposed and schedule a public hearing on the proposed Local Law to allow the citizens of Harpersfield an opportunity to voice their thoughts and provide feedback on the proposed Local Law.

NOW, THEREFORE, BE IT RESOLVED that the Town Board accepts the proposed draft local law that has been introduced; and

BE IT FURTHER RESOLVED, that a copy of the proposed draft Local Law shall be placed in the Town Clerk's office and made available for public inspection; and

BE IT FURTHER RESOLVED, that the Town Board will hold a public hearing for consideration of the Local Law on September 09, 2026 at 7:00pm at the Town Hall; and

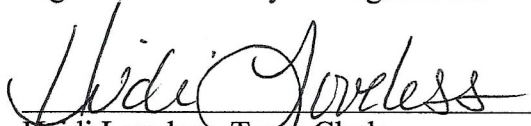
